### THIS IS A PRELIMINARY LIST OF NOMINEES

The listed nominees have been duly nominated for the offices of Chief Councillor and Council for the Haisla Nation in accordance with the *Haisla Nation Custom Election Code (2021)*. The Electoral Officer will make best efforts to contact each nominee and inform them that they have been nominated.

#### **ELIGIBILITY FOR CANDIDACY**

- a) Must be listed on the Haisla Nation (Kitamaat) Indian Registry and at least eighteen (18) years old as of the date of the Nomination Meeting.
- b) Must not be in arrears (has an outstanding debt) \$500.00 or greater to Haisla Nation Council.
- c) Must be a Local Resident if running for a Councillor position.

**ACCEPTANCE - To become a candidate, nominees must deliver to the Electoral Officer or Deputy Electoral Officer by 4:00 PM on June 12, 2025, the following:**

- 1. a signed Notice of Acceptance of Nomination for only one Office;
- 2. a sworn Declaration confirming their eligibility as a candidate; and
- 3. a deposit of \$100.

**DEPOSIT** - The deposit shall be in the form of cash, money order, or certified cheque payable to OneFeather Mobile Technologies Ltd. These funds shall be held in trust until after the appeal period has expired, in the case where no election appeal has been filed in accordance with the Election Code, or after all appeals have been decided. The Electoral Officer will issue a cheque in the amount of the deposit (\$100) to each candidate who has received at least 15% of the total votes cast at the election. The remaining funds will be forfeited to the Haisla Nation.

**WITHDRAWAL** - A candidate may withdraw their candidacy at any time prior to the close of the polls by submitting to the Electoral Officer a written declaration of withdrawal in the form prescribed, signed by the candidate in the presence of the Electoral Officer, a justice of the peace, a notary public, or a commissioner for oaths. **If a candidate withdraws by June 16, 2025, their name will not appear on the ballot.** If a candidate withdraws after this date, their name shall remain on the ballot. A candidate who withdraws forfeits any candidate deposit they have paid, and any votes cast for them will be void.
